Prospective Bidders and all concerned are hereby informed that the following addendum is made. This addendum is to be signed by all Prospective Bidders at time of purchase of Bid Documents or otherwise returned to the Township Engineer via e-mail, facsimile, or hand-delivery.

Acknowledgment of this addendum shall also be recorded within the Bid Documents on the "ACKNOWLEDGEMENT OF RECEIPT OF CHANGES TO BID DOCUMENT FORM".

All prospective bidders are hereby notified of the following changes and additions to the Bid Documents as noted below:

1. **The bid opening date for MONMOUTH ROAD STORM SEWER IMPROVEMENTS has been changed from Tuesday, July 26, 2022 at 10:00 AM to Tuesday, August 2, 2022 at 10:00 AM.**
2. The cutoff date for written inquiries is July 29, 2022 at 10:00 AM.
3. Page P-5, on the Bid Form: "Pay Item No. 14 – 6"x8"x18" Concrete Vertical Curb (IAWD)" pay item quantity AND "Pay Item No. 19 – No Item" pay item name, quantity, and unit shall be changed as follows:

4. Contractor may remove bid form from specification and use bid form provided with Addendum No. 1 or may use a corrected original bid form for the project prior to submitting bid. Should the Contractor use the original bid form, it shall be understood and corrected so that the pay item quantity for Pay Item No. 14 has been changed and that the pay item name, quantity, and unit for Pay Item No. 19 has been changed.
5. The following line in the Supplementary Specifications on Page 21, under Subsection 108.10 CONTRACT TIME, shall be changed as follows:
The bid opening date for this project is **August 2, 2022 at 10:00 AM.**
6. The following Section has been added to the Supplementary Specifications:

SECTION 606 – SIDEWALKS, DRIVEWAYS, AND ISLANDS

606.01 DESCRIPTION

THE FOLLOWING IS ADDED:

Concrete sidewalk shall be installed as directed. If the Contractor damages any sidewalk during construction, the sidewalk shall be removed and replaced at no cost to the Owner. The Contractor shall layout the location of sidewalk and handicap ramp construction prior to commencing any construction procedures. Upon Engineer's approval of the aforementioned layout, the Contractor will be permitted to begin construction.

The Contractor shall remove the existing depressed curb, concrete sidewalk, and handicap ramps in the areas designated on the construction plans or as directed in the field. There is no specific payment for the removal of such items, and the cost associated with this work should be included in the lump sum bid for Clearing Site.

This Contractor is responsible for notifying the adjacent property owner at a minimum of two (2) weeks in advance of any construction work being performed in the area of their site. The Contractor is also responsible for maintaining access to the site for the duration of the project.

In no way shall any resident lose use of their driveway at the end of any work day. Place and compact aggregate at the end of work day and maintain such surface until the final driveway is placed. Cost of such work should be included in the unit prices bid for respective items.

All handicap ramps shall be constructed as per current ADA Standards.

606.04 MEASUREMENT AND PAYMENT

The Department will measure and make payment for Items as follows:

<u>Pay Item</u>	<u>Pay Unit</u>
CONCRETE SIDEWALK, 4" THICK (IAWD)	SQUARE YARD

THE FOLLOWING IS ADDED:

Sidewalks of the various kinds and thickness will be measured by the square yard.

The sidewalk shall be tied into existing sidewalk, if and where directed, by the Engineer in the field. The sidewalk shall be tied into the existing sidewalk at a slope no more than 2%.

Concrete ramp construction and forming of the delineation sub-base shall be included in the unit price bid for CONCRETE SIDEWALK, 4" THICK (IAWD) in the Proposal.

There is no specific payment for the mechanical sawcut at all limits of work, and the cost thereof should be included in various items in the proposal.

Payment for the removal and disposal of any existing depressed curb, and/or sidewalks and all adjacent site restoration, unless payment is otherwise provided for under other pay items, will be included in the lump sum bid item CLEARING SITE in the proposal.


The cost for providing a stable sub-base for the proposed concrete sidewalk using dense graded aggregate shall be included in the cost for appropriate sidewalk pay items. The thickness of dense graded aggregate needed to provide a stable sub-base is subject to the Engineer's approval.

CONCRETE SIDEWALK, 4" THICK (IAWD) shall be constructed on an "if and where directed" basis and only those areas authorized for new sidewalk will be paid for by the Owner.

Prospective Bidder hereby confirms that he or she has received and reviewed this document and all its contents and accepts this information as part of the Contract. Each Bidder should return a copy of this signed addendum via e-mail, facsimile, or hand-delivery and indicate receipt within his or her bid submission.

BIDDER acknowledges that in the event of a discrepancy between the unit price for any pay item and the extended price shown for that item, the unit price is to govern. Where a unit price is bid for an item but no extended price is provided, the extended price shall be established by multiplying the unit price and the estimated quantity. Where the extended price is provided and the unit price is not provided, the unit price shall be established by dividing the extended price by the estimated quantity. Where no figure is provided for the unit price and extended price, the amount bid will be considered to be zero (\$0.00).

BIDDER acknowledges that estimated quantities are not guaranteed, and are solely for the purpose of comparison of Bids, and final payment for Unit Price Bid items will be based on actual quantities, determined as provided in the Contract Documents.

The Contractor understands that the OWNER reserves the right to reject any or all bids. Any omission of the mention of any of the detail work to be performed under each item does not relieve the Contractor from their obligation to complete each and every item of work contracted for as called out in the specifications necessary to complete the entire work.

Contractor understands that any supplemental work shall be authorized by the OWNER and the State of New Jersey and actual payment for supplemental work orders shall be paid for the actual recorded labor, materials, equipment and a maximum overhead and profit of twenty percent (20%), as reported on an approved data sheet provided by the OWNER.

Failure to bid on all items shall result in an informal bid and subsequent disqualification.
